- HVAC Maintenance at the listed locations and provision of services to HVAC equipment adhering to the Manufacturer's Specifications and Designs.
- Regularly scheduled maintenance of HVAC equipment at each location.
- Each scheduled inspection shall cover a thorough check of each piece of equipment and will provide a written report on any findings, recommendations for repairs or reconditioning work, together with a list of parts and accessories, as well as a list of completed tasks.
- Any recommendations would include a list of itemized proposals covering material, parts, and labor costs.
